Training Institute Australasia Fees for 2023 WA Government Subsidised are as below:

1. These fees are estimates only for students enrolling in (or currently enrolled in) Government subsidised qualifications and courses in 2023.
2. The indicative fees for a course may differ between training providers due to the units of competency they have included in the course stream. The differences generally result from adapting courses to meet local industry needs or workplace requirements.
3. Nominal hours are not hours of training or instruction. They are used to determine course fees and subsidy levels to reflect the cost to deliver quality training and formerly called implementation guides.
4. Concession and annual course fee caps may also apply to some courses. Fee caps apply to some tuition fees only. Note: Proof of eligibility for concession must be demonstrated prior to the commencement of the unit. If the concession is valid for the full enrolment period, then all eligible units commenced within that period attract the concession rate. If the concession is valid for part of the enrolment period, then only eligible units
5. Commenced units of competency prior to the expiry of the concession attract the concession rate.
6. Fees have been quoted on the basis of 2023 fee rates only. These are potentially subject to change in 2023.
7. Other charges may apply.
8. Youth means a person who has reached 15 years of age and is under 25 years old and a fee cap of \$400 applies for a calendar year for a targeted fee relief course in 2023.
9. Some courses are course fee free in 2023 which are noted below in the table if the student is eligible in Green.

The student tuition fees are indicative only and are subject to change given individual circumstances at enrolment. Additional fees may apply such as student service and resource fees.

* The maximum course fee for non-concession students undertaking a targeted fee relief course in 2023 is \$1,200 (excluding resource fees if applicable) For concession students and youth, the maximum course fee for undertaking a targeted fee relief course in 2023 is \$400. These maximums apply per course in 2023.

**Fee caps for secondary school-aged persons not enrolled at school

For secondary school-aged persons not enrolled at school, the maximum course fee chargeable in 2023 is \$420. 200 (excluding resource fees if applicable)
